Dear Friends,

At the ESC General Assembly on May 18th serious concern was expressed about the public consultation procedure that has been initiated recently by the EU Home Affairs directorate on «reducing the harm caused by criminal use of firearms»

This public consultation procedure is part of a campaign that can have very serious consequences for sport shooters if the EU Firearms Directive is amended by 2015.

The Commission's main objective in organizing this public consultation is to obtain some legitimacy from the public opinion in order to make the existing EU rules on legal acquisition, possession and transportation of civilian firearms, including sports firearms, more restrictive. The consequences can become dramatic for all sportsmen, affecting licensing, transportation, acquisition of arms, the development of the shooting sport for junior sportsmen and international competitions.

Various organizations representing the interests of sport shooters and other stakeholders – the European Shooting Sport Forum (ESSF), the European Shooting Sport Council (ESSC), the Federation of Associations of hunters and conservationists of the EU (FACE) have already called upon their members to react to this consultation. It is very important that all the national sport shooting federations in EU member countries replied to the questionnaire of the public consultation – and it is even more important that they encouraged as many members as possible to do likewise.

Even if we manage to involve 20 answers to the questionnaire from each Federation and our members show no support for further restrictions or EU action on firearms rules, it will be difficult for the Commission to use public opinion as an excuse for reviewing the Firearms Directive.

Practically all of the 25 questions in the consultation are deliberately prepared in such a way as to obtain answers that will provoke tightening of the legislation regulating firearms in Europe.


The deadline for answering the questions of the public consultation is June 17th. The answers can be given only via the internet, on the site of the European Commission.

We suggest to have the questionnaire completed as follows:

1. Go to <http://ec.europa.eu/yourvoice/ipm/forms/dispatch?form=ReduceFirearmsRisk>
2. Choose your language in the icon that is in the upper right part of the screen.
3. Indicate your country, whether you are an individual or an organisation and your name or the name of your organisation.
4. Answer the questions by clicking on option “1” for each one of them. For some questions, it may seem that answering option 1 is a bit extreme but it should be borne in mind that virtually all questions are biased and have been formulated precisely to compel the reader to agree that some EU action is needed. Furthermore, national legislation on all issues addressed in the questions already exists. You do not need to answer the optional questions that request additional comments (questions B.4, C.11, D.5 and E.6).
5. After having answered the questions, as a security measure to avoid computer-generated replies, you will have to type in the numbers and/or letters that will be displayed in your screen and validate them.
6. Your answers will have been submitted by then. You can view them and/or save them as a PDF (by pressing «export as PDF» button).
7. We ask you and your members to save copies of your answers as .pdf files and send them to the ESC secretariat to esc@escsport.eu

The public consultation is just the first stage of this work – we will keep you informed of further progress.
